SECTION 4: SITE ACCESS INFORMATION

- Operating hours for the Drury Managed Fill operation are Monday to Thursday 7.00am to 4.45pm, Friday 7.00am to 3.45pm, Saturday 7.00am to 11.45am.
- Operating hours for the Tūākau Sand Quarry Cleanfill operation are Monday to Friday 7.30am to 5:00pm, Saturday 7.30am to 12:00pm.
- The speed limit in the quarry, sand plant or fill site is 20kmh.
- Engine brakes must NOT be used:
 - Drury Quarry:**
 - In the quarry zone
 - Maketu Rd between Ramarama roundabout and Bill Stevenson Drive
 - Fitzgerald Road
 - Tūākau Sand Quarry:**
 - On Friedlander Road
 - Within 500m of the intersection of Friedlander and Buckland roads
- Do NOT slam tailgates.
- Use of wheel wash is compulsory when exiting Drury and Tūākau quarries.
- Dusty loads should be covered to avoid dust nuisance.
- PPE required before exiting cab within quarry and fill sites: hard hat, safety glasses, gloves, long sleeved shirt, long pants and high viz.

SECTION 5: STEVENSON TERMS FOR USE OF FILL OPERATIONS

- Account Holder shall ensure that all fill material disposed of at this site is within the criteria / limits outlined in the information provided.
- Any changes to charges that occur due to onsite Inspections and / or screening. For example, Class 5 charges being changed to Class 3 & 4 will be at Account Holder’s liability.
- All information provided to Stevenson is true and accurate.
- Any fill material disposed of at Stevenson sites that do not meet the criteria or is deemed unacceptable and is rejected by Stevenson (at its sole discretion and at any time) will be removed at Account Holder’s cost.
- Stevenson reserve the right to suspend the fill operations at any time for any duration.
- Stevenson do not accept any liability for costs associated with the closure.
